REBECCA VENNERI APPLICANT	: ORDER SUSPENDING APPLICATION FOR LICENSED PROFESSIONAL COUNSELOR

The Professional Counseling Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board (Section) issued an Order on October 21, 2013, to Rebecca Venneri finding that she had violated Wis. Admin. Code §§ MPSW 20.02(23) and (11) and as such, was subject to discipline pursuant to Wis. Stat. § 457.26(2)(f). The October 21, 2013, Order required Ms. Venneri to pay costs in the amount of \$450 within 90 days of the Order. If costs were not paid in a timely manner, the Order provided that Ms. Venneri's application for licensure may, in the discretion of the Section or its designee, be suspended, without further notice or hearing, until Ms. Venneri has complied with the payment of costs and all other terms of the Order. To date, Ms. Venneri has not paid the requisite costs.

Pursuant to the October 21, 2013 Order and Wis. Stat. § 457.26, the Section suspends Ms. Venneri's application for licensure as a Professional Counselor until such time as she complies with the Order.

IT IS HEREBY ORDERED that Rebecca Venneri's application for licensure as a Professional Counselor is SUSPENDED.
