On November 14, 2013, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license. Respondent was ordered to complete three (3) hours of education on sharpening critical thinking skills, five (5) hours on documentation, five (5) hours on professional accountability and legal liability for nurses and three (3) hours on righting a wrong hours of education.

Respondent has submitted proof that she successfully completed the Board-ordered education and, as a result, the following is entered:

1. Respondent's professional nursing license (#104834-30) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
