On December 3, 2013, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$350.00 in costs of the proceeding and complete six (6) hours of education in "ethics for social workers" both within 90 days. On March 25, 2014, Respondent's social work credential was suspended for failure to pay the costs of the proceeding and to complete the education as ordered.

Based upon the information of record, which includes proof that Respondent has now paid the costs and completed the education, the following is entered:

ORDER

1. The suspension is terminated and Respondent's social work credential (#4550-120) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
