On December 3, 2013, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$251.43 in costs of the proceeding within ninety days and complete six (6) hours of education in "ethics of documentation.", within one hundred and twenty days from the date of the Order.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the Board-ordered education and, therefore, the following is entered:

ORDER

1. Respondent's social work certificate (#10097-120) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full and has demonstrated successful completion of the education requirements of the Order.
3. This order is effective the date of its signing.
