On January 14, 2014, the Wisconsin Auctioneer Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$733.00 in costs of the proceeding within 90 days. On May 9, 2014, Respondent's auction company credential was suspended for failure to pay the costs of the proceeding as ordered.

Based upon the information of record, which includes proof that Respondent has now paid the costs of the proceeding in full, the following is entered:

ORDER

1. The suspension is terminated and Respondent's auction company credential (#226-53) is hereby returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
