On February 20, 2014, the Wisconsin Department of Safety and Professional Services ("Department") issued a Final Decision and Order ("Order") requiring Respondent to pay \$78.00 in costs of the proceeding and complete 40 hours of education in accordance with the continuing education requirements specified in Wis. Admin. Code § SPS 135.02, both within 90 days from the date of the Order.

The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and to complete the education requirements and, therefore, the following is entered:

ORDER

1. Respondent's home inspector license in the state of Wisconsin (#2002-106) is hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding in full, plus interest, and has demonstrated successful completion of the education requirements of the Order.
3. This order is effective the date of its signing.
