ORDER OF SUMMARY SUSPENSION

The Petition for Summary Suspension dated March 31, 2014 was noticed to be presented at 8:00 a.m., or as soon thereafter as the matter could be heard, on April 10, 2014. At that time, Attorney Andrea Brauer appeared for the Petitioner, the Department of Safety and Professional Services, Division of Legal Services and Compliance. Respondent did not appear for the Summary Suspension proceeding.

The Board of Nursing (Board), having considered the sworn Petition for Summary Suspension; the signed Petition for Designation of Hearing Official, the Affidavits of Steven A. Rohland, and Lori Hahn; the disciplinary orders and related records from the states of North Dakota and Arizona; patient profile records of Daniel Giles and Sabrina Giles from ND Pharmacy in North Dakota; and, having heard the arguments of counsel, hereby makes the following:

### FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. The Petition for Summary Suspension (with attachments) and Petition for Designation of Hearing Official are adopted as accurate and incorporated into this Order in their entirety. The Board finds such Petitions to contain accurate findings of fact and conclusions of law.

2. The Board has jurisdiction over this matter pursuant to Wis. Stat. 441.07 and has authority to summarily suspend the professional nursing license of Sabrina C.K. Giles, R.N. (license number 144136-30), pursuant to Wis. Stat. § 227.51(3) and Wis. Admin. Code ch. SPS 6.

3. As evidenced by the Petition for Designation of Hearing Official, dated March 31, 2014, notice has been given pursuant to Wis. Admin. Code § SPS 6.05.

4. Based on the evidence presented, there is probable cause to believe that the Respondent, Sabrina C.K. Giles, has engaged in and/or is likely to engage in conduct such that the public health, safety or welfare imperatively requires emergency suspension of the Respondent's license, based upon the following conduct by the Respondent:

a. Respondent has a persistent history of impairment dating back to at least October of 2012.

- b. Respondent, through repeated violations of laws related to the practice of nursing, shows no signs of rehabilitation.
- c. Respondent, though offered multiple opportunities to provide evidence of treatment or other evidence of rehabilitation, has not done so.
- d. Respondent has repeatedly failed to respond to the Division's efforts to contact her on behalf of the Board, for purposes of the Board's investigation. Therefore, Respondent has made it impossible for the Board to conclude anything other than that Respondent remains unable to safely and reliably engage in the practice of nursing practices.
- e. Respondent has not responded to the Division's inquiries on behalf of the Board. Respondent has made it impossible for the Board to adequately monitor her.

5. Based upon the affidavits and/or other evidence presented during the Summary Suspension proceeding on April 10, 2014, the public health, safety or welfare imperatively requires emergency suspension of the Respondent's professional nursing license.

## **ORDER**

1. The Respondent's license to practice as a professional nurse in the State of Wisconsin, and her privilege to practice under the Nurse Licensure Compact in Wisconsin, is summarily suspended until the effective date of a final decision and order issued in the disciplinary proceeding against Respondent Sabrina C.K. Giles, unless otherwise ordered by the Wisconsin Board of Nursing.

2. Respondent Sabrina C.K. Giles is hereby notified of her right, pursuant to Wis. Admin. Code § SPS 6.09, to request a hearing to show cause why this summary suspension order should not be continued and is further notified that any request for a hearing to show cause should be filed with the Wisconsin Board of Nursing, 1400 East Washington Avenue, P.O. Box 8935, Madison, Wisconsin 53708.

In the event that Respondent Sabrina C.K. Giles, requests a hearing to show cause why the summary suspension should not be continued, that hearing shall be scheduled to be heard on a date within 20 days of receipt by the Wisconsin Board of Nursing of Respondent's request for hearing, unless Respondent requests or agrees to a later time for the hearing.
