On April 22, 2014, the Wisconsin Radiography Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's radiography license. Respondent was required to complete 3 hours of education on radiation safety, and 2 hours in patient care pursuant to the Order.
