FINDINGS OF FACT

- 1. CALVIN BRACE (Applicant) has filed an application for a credential to practice as a substance abuse counselor-in-training in Wisconsin.
- 2. Information received in the application process reflects the following convictions:
 - On 09/22/99 Disorderly Conduct
 - On 08/09/00 Receiving Stolen Property
 - On 04/25/01 Criminal Damage to Property; Disorderly Conduct
 - On 08/27/01 Battery; Substantial Battery Intend Bodily Harm (Party to a Crime)
 - On 09/25/02 Battery Attempt; Resisting or Obstructing an Officer
 - On 02/11/03 Disorderly Conduct
 - On 11/16/04 Criminal Damage to Property; Criminal Trespass to Dwelling
 - On 08/14/08 Disorderly Conduct; Intimidate Victim/Dissuade Reporting

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Safety and Professional Services has jurisdiction over this matter pursuant to Wis. Stat. §440.88.
- 2. The facts and circumstances of the past convictions are substantially related to your request for licensure as a substance abuse counselor-in-training.

ORDER

NOW, THEREFORE, IT IS ORDERED that CALVIN BRACE is GRANTED A SUBSTANCE ABUSE COUNSELOR-IN-TRAINING LICENSE subject to the following LIMITATIONS, TERMS AND CONDITIONS:

Practice Limitations

- 1. Applicant shall complete an alcohol and drug abuse assessment PRIOR to receiving his limited license and beginning practice as a substance abuse counselor-in-training. Applicant shall coordinate with the Department Monitor to ensure department approval of the entity performing his assessment prior to beginning the assessment. Applicant shall provide the Department Monitor with the original copy of the completed assessment. Information on how to contact the Department Monitor is listed in paragraph six of this Order. Applicant shall comply with the terms and conditions of the completed assessment in order to receive his limited license and maintain it once it has been issued.
- 2. Applicant shall provide a copy of this Order to all prospective employers.
- 3. Applicant shall commit no new violations of law, and shall report all law enforcement contacts leading to arrest, charge, or conviction to the Department Monitor within 48 hours of any such event.

Reporting Requirements

- 4. It is Applicant's responsibility to arrange for his supervisor(s) to provide work reports to the Department Monitor on a quarterly basis, as directed by Department Monitor. These reports shall describe the Applicant's activities and verify that he is in compliance with the laws governing the practice of a substance abuse counselor-in-training and the terms of this Order.
- 5. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others. Applicant shall promptly notify Department Monitor of any suspected violations of any of the terms and conditions of this Order by Applicant.

Department Monitor

6. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

Term of the Order

7. The terms and conditions of this Order shall be effective throughout the entire term of the Applicant's substance abuse counselor-in-training license and cannot be modified.

Costs

8. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

Summary Suspension/Additional Discipline

9. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Applicant's license. The Department, in its discretion, may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event that Applicant fails to submit quarterly reports as ordered, Applicant's license may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Applicant has complied with the terms of this Order.
