The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Medical Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent Govindaraju Subramani, M.D. (dob July 16, 1949), is licensed in the state of Wisconsin to practice medicine and surgery, having license number 28095 - 020, first issued on October 24, 1986, with registration current through October 31, 2015. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 3513 Cambridge Ct., Unit 105, Danville, IL 61832-7948.

2. The investigation of this matter resulted from Respondent's report of discipline in another jurisdiction, as required by Wis. Admin. Code § 10.03(3)(a).

3. On December 11, 2013, Respondent entered into a Consent Agreement with the State Medical Board of Ohio (case no. 13 –CRF-043) whereby the restoration of his certificate to practice medicine and surgery in the state of Ohio was suspended for not less than one year.

4. The facts giving rise to the Consent Agreement are as follows:

- a. on or around December 2011, Respondent submitted an application to have his Ohio medical license reinstated. By signing the application, he certified that all statements made in connection with the application were true;
- b. Respondent answered “no” to an application question asking if he had ever pled guilty to, been found guilty of a violation of any law, or been granted intervention or treatment in lieu of conviction regardless of the legal jurisdiction in which the act was committed, other than a minor traffic violation;
- c. in response to questions from an Ohio board investigator about his “no” response to the above question, Respondent admitted to two DUI arrests and convictions in 2002 and 2008, occurring outside of Ohio, but specifically denied any DUI or alcohol-related arrests in Ohio; and
- d. prior to applying for reinstatement of his Ohio medical license, Respondent had in fact been convicted of violations of law (excluding minor traffic offense), and/or summoned into court as a defendant. In addition to the two DUI arrests and convictions in 2002 and 2008, Respondent also had: (1) an OMVI (Operation of a Motor Vehicle While under the Influence of Alcohol and/or Drugs) conviction in 1985; (2) a Reckless Operation of a Motor Vehicle conviction in 1986; and (3) a Reckless Operation of a Motor Vehicle conviction in 1988.

5. Pursuant to the Consent Agreement, it was determined that in the process of applying to have his Ohio medical license re-instated, Respondent made a false, fraudulent, deceptive, or misleading statement in relation to the practice of medicine and surgery on both the application form and in response to questions by a Board investigator regarding same, which constitutes violation of applicable provisions of the Ohio Revised Code governing the practice of medicine and surgery.

#### CONCLUSIONS OF LAW

1. The Wisconsin Medical Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 448.02(3), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

2. As set forth in the Findings of Fact, by knowingly engaging in fraud or misrepresentation or dishonesty in applying for or procuring a medical license, Respondent

Govindaraju Subramani, M.D., engaged in unprofessional conduct pursuant to Wis. Admin. Code § Med 10.03(1)(b).

3. As set forth in the Findings of Fact, by having his license to practice medicine and surgery in the state of Ohio suspended, Respondent Govindaraju Subramani, M.D., engaged in unprofessional conduct pursuant to Wis. Admin. Code § Med 10.03(3)(c).

4. As a result of the above conduct, Govindaraju Subramani, M.D. is subject to discipline pursuant to Wis. Stat. § 448.02(3).

ORDER

1. The attached Stipulation is accepted.

2. Respondent, Govindaraju Subramani, M.D. (license number 28095-020), is REPRIMANDED.

3. Within ninety (90) days of the date of this Order, Govindaraju Subramani, M.D., shall pay COSTS of this matter in the amount of \$233.83.

4. Payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Respondent to the Department Monitor at the address below:



STIPULATION

Respondent Govindaraju Subramani, M.D. and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Medical Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order if adopted in the form attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.



The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
