On June 10, 2014, the Wisconsin Cosmetology Examining Board ("Board") issued a Final Decision and Order ("Order") requiring each Respondent pay \$500.00 in forfeiture, for a combined total of \$1,000.00, within 90 days. On November 17, 2014, the Board considered Respondents' request for a payment plan. Based upon the information of record, the Board finds and makes the following:

#### **ORDER**

- 1. Respondents' request for a payment plan is hereby GRANTED. Each Respondent shall pay \$50.00 per month, for a total monthly payment of \$100.00, for 10 months beginning in November 2014.
- 2. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
