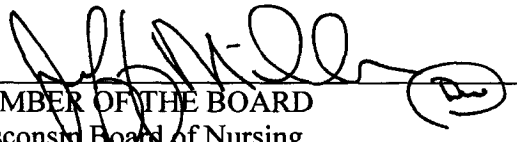

The Wisconsin Board of Nursing ("Board") issued an Administrative Warning to the Respondent in the above-captioned matter on February 13, 2014.

Pursuant to the authority granted in Wis. Stat. § 440.205 and Wis. Admin. Code ch. SPS 8, the Respondent requested a review of the Administrative Warning. That review was held on July 10, 2014 before the Board. The Respondent declined a personal appearance but asked that a written submission be provided to the Board. The Department of Safety and Professional Services, Division of Legal Services and Compliance did not appear.

After consideration of the Respondent's submission and based upon the information of record,

IT IS HEREBY ORDERED that the Administrative Warning issued to Respondent in case number 13 NUR 622 is AFFIRMED.
