The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Veterinary Examining Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

### **FINDINGS OF FACT**

1. Respondent Alison M. French, D.V.M., (dob May 1, 1973) is licensed in the state of Wisconsin to practice veterinary medicine, having license number 4922-50, first issued on May 21, 1999, and current through December 14, 2015. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 1117 South Oneida Avenue, P.O. Box 1186, Rhinelander, Wisconsin 54501.

2. At all times relevant to this proceeding, Respondent was employed as a veterinarian at French's Homestead Veterinary Care Clinic (Clinic), located in Rhinelander, Wisconsin.

3. Respondent owns French's Homestead Veterinary Care Clinic.

4. Respondent employed and supervised M.J. as a veterinarian after M.J. was granted a temporary permit to engage in the practice of veterinary medicine.

5. M.J.'s temporary license expired on January 17, 2013. Respondent failed to terminate M.J.'s employment when M.J's temporary permit expired.

6. Respondent continued to supervise M.J. and permitted M.J. to continue to engage in the unlicensed practice of veterinary medicine between January 17, 2013 and February 18, 2014.

7. The general public, including Respondent, has online access to the status of temporary licenses issued by the Board.

8. Respondent states that, due in part to M.J.'s misrepresentations; she was unaware that M.J.'s temporary license had expired.

9. In resolution of this matter, Respondent consents to the entry of the following Conclusions of Law and Order.

## CONCLUSIONS OF LAW

1. The Wisconsin Veterinary Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. 453.07(2), and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. 227.44(5).

2. Wiscosnin Stat. § 453.05(1), states: "Except as provided under sub. (2) and § 257.03, no person may offer to practice, advertise to practice or practice veterinary medicine, or use, in connection with his or her name, any title or description which may convey the impression that he or she is a veterinarian, without a license or temporary permit from the examining board."

3. By the conduct described in the Findings of Fact, Alison M. French, D.V.M., violated Wis. Stat. § 453.07(1)(b), by violating this chapter or ch. 440 or any federal or state statute or rule which is substantially related to the practice of veterinary medicine.

4. By the conduct described in the Findings of Fact, Alison M. French, D.V.M., engaged in unprofessional conduct as defined in Wis. Admin. Code § VE 7.06(4), by violating or aiding and abetting the violation of any law or administrative rule or regulation substantially related to the practice of veterinary medicine; to wit Wis. Stat. § 453.05(1).

5. As a result of the above violations, Alison M. French, D.V.M., is subject to discipline pursuant to Wis. Stat. § 453.07(2)(a).

# <u>ORDER</u>

1. The attached Stipulation is accepted.

2. Respondent Alison M. French, D.V.M., is REPRIMANDED.

Within ninety (90) days from the date of this Order, Alison M. French, D.V.M., 3. shall pay COSTS of this matter in the amount of \$95.00.

Payment of costs (made payable to the Wisconsin Department of Safety and 4. Professional Services) shall be sent by Respondent to the Department Monitor at the address below:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Respondent's license. The Board in its discretion may in the alternative impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event Respondent fails to timely submit payment of costs as ordered, Respondent's license (no. 4922-50) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Respondent has complied with payment of costs.

6. This Order is effective on the date of its signing.

Respondent Alison M. French, D.V.M., and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.

2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Respondent;
- the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
- the right to testify on Respondent's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Veterinary Examining Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.

5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
