On September 3, 2014, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's dental license (#2962-15) for an indefinite period. Respondent may petition for a stay of suspension after providing proof, which is determined by the Board or its designee to be sufficient, that Respondent is in compliance with the provisions of Sections C and D of this Order.

Respondent's petition for an initial stay of suspension has been reviewed pursuant to the Order. Based upon the information of record, which demonstrates that Respondent qualifies for a stay of suspension at this time, the following is entered:

ORDER

1. The suspension of Respondent's dental license (#2962-15) is hereby STAYED.
2. The stay is continuous, contingent upon Respondent's compliance with the terms and conditions of the Order.
