On May 9, 2014, the Wisconsin Board of Nursing (Board), via motion, voted to deny the Applicant's application for licensure as a Licensed Practical Nurse because her conviction record substantially related to the practice of a Licensed Practical Nurse. On May 15, 2014, the Board issued a denial letter to the Applicant advising her of the denial of her application. The Applicant filed a timely request for hearing. The Division of Legal Services and Compliance, Department of Safety and Professional Services (Division) petitioned the Board for reconsideration of the denial arguing that the Applicant's conviction record was not substantially related to the practice of a Licensed Practical Nurse and that the denial should be rescinded.

On October 9, 2014, the Board considered the Division's petition, along with the Division's verbal argument and written submissions, and decided to rescind the denial of Applicant's application for licensure as a Licensed Practical Nurse. The Board found, via motion, that the Applicant's conviction record, as of October 9, 2014, was not substantially related to the practice of nursing.

ORDER

The denial of the application of JANA K. JUNGWIRTH for LICENSURE AS A LICENSED PRACTICAL NURSE is hereby RESCINDED. The May 9, 2014 Board motion concerning such denial is rescinded and the May 15, 2014 letter confirming the denial are rescinded. Ms. Jungwirth's application for licensure as a Licensed Practical Nurse remains open. There is no Board order in effect denying Ms. Jungwirth the opportunity to sit for the NCLEX exam. As such, Mr. Jungwirth's appeal is dismissed. The Division Case number 14 NUR 362, opened as a result of Ms. Jungwirth's request for hearing, is closed due to lack of jurisdiction. The Board will reconsider Ms. Jungwirth's application once it is complete.
