The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Board of Nursing (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

1. Licensee Michelle L. Glodowski, R.N., (dob May 9, 1972) is licensed in the State of Wisconsin as a professional nurse, having license number 124655-30, first issued on October 22, 1996 and current through February 29, 2016. Licensee's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is R7698 Duncan Road, Hatley, Wisconsin 54440-9727.

2. At all times relevant to this proceeding, Licensee was employed as a professional nurse at a nursing home (Home), located in Minocqua, Wisconsin.

3. On July 4, 2013, at 2:29 p.m., Resident A complained of chest and left arm pain. Licensee was able to palpate and reproduce the pain to his left upper arm. Licensee took Resident A's blood pressure which was 200/110. Licensee also documented in nursing notes that Resident vague about his chest pain with palpitation.
4. Licensee called a practical nurse, S.K., to bring a cuff oxygen saturation machine and nitroglycerin. Resident A's oxygen saturation was 83-92%.
5. At 2:47 p.m., Licensee administered nitroglycerin to Resident A. Licensee also performed a simple neurological assessment on Resident A which did not show any deficits.
6. Resident A reported that he felt a little better after taking the nitroglycerin.
7. About 2:55 p.m., Licensee rechecked Resident A's blood pressure which was 146/84. Licensee administered Tylenol and a warm neck compress for pain.
8. At 3:03 p.m., Licensee rechecked Resident A's oxygen saturation which was 89-90% and took his blood pressure.
9. By 4:00 p.m., Resident A was up to use the restroom and showed no signs of acute distress.
10. Licensee left shortly after 4:00 p.m. and reported all of the above information to practical nurse S.K., who took over Resident A's care. Before leaving for the day, Licensee completed all charting and other nursing tasks.
11. Licensee correctly documented all of the information above but failed to contact Resident A's physician or send Resident A to the emergency room for an evaluation of a possible myocardial infarction.
12. Due to concerns Licensee had with the Home and reduction in hours, she decided to seek other employment and reported her concerns to the Department of Health Services.
13. In resolution of this matter, Licensee consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

1. The Wisconsin Board of Nursing is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

ORDER

1. The attached Stipulation is accepted.

2. Within six (6) months of the date of this Order, Michelle L. Glodowski, R.N., shall at Licensee's own expense take and successfully complete four (4) hours of education on the topic of cardiac assessment in the older adult and five (5) hours of education on the topic of professional accountability and legal liability for nurses as follows:

- a. Each course attended in satisfaction of this Order must be pre-approved by the Board or its designee. Licensee shall be responsible for locating course(s) satisfactory to the Board and for obtaining the required approval of the courses from the Board or its designee. Licensee must take and pass any exam offered for the course(s).
- b. Licensee shall submit proof of successful completion of the education in the form of verification from the institution providing the education to the Department Monitor at the address stated below. None of the education completed pursuant to this requirement may be used to satisfy any education requirements that have been or may be instituted by the Board or Department.

3. Within 120 days from the date of this Order, Licensee shall pay COSTS of this matter in the amount of \$1,000.00.

4. Request of approval of courses, proof of successful course completion and payment of costs (made payable to the Wisconsin Department of Safety and Professional Services) shall be sent by Licensee to the Department Monitor at the address below:

5. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Licensee's license. The Board in its discretion may in the alternative impose additional conditions and limitations for a violation of any of the terms of this Order. In the event Licensee fails to timely submit payment of the costs as ordered or fails to submit proof of successful completion of the ordered education as set forth above, Licensee's license (no. 124655-30) may, in the discretion of the Board or its designee, be SUSPENDED, without further notice or hearing, until Licensee has complied with payment of the costs and submitted proof of successful completion of the ordered education.

6. This Order is effective on the date of its signing.

Licensee Michelle L. Glodowski, R.N., and the Division of Legal Services and Compliance, Department of Safety and Professional Services, stipulate as follows:

1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Licensee consents to the resolution of this investigation by Stipulation.

2. Licensee understands that by signing this Stipulation, Licensee voluntarily and knowingly waives the following rights:

- the right to a hearing on the allegations against Licensee, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
- the right to confront and cross-examine the witnesses against Licensee;
- the right to call witnesses on Licensee's behalf and to compel their attendance by subpoena;
- the right to testify on Licensee's own behalf;
- the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
- the right to petition for rehearing; and
- all other applicable rights afforded to Licensee under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.

3. Licensee is aware of Licensee's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.

4. Licensee agrees to the adoption of the attached Final Decision and Order by the Wisconsin Board of Nursing (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Licensee waives all rights to any appeal of the Board's order, if adopted in the form as attached.


5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division of Legal Services and Compliance for further proceedings. In

the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.


6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Licensee, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.

7. Licensee is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.

8. The Division of Legal Services and Compliance joins Licensee in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
