FINDINGS OF FACT

1. Valerie Rislove (Applicant) applied for licensure as a registered nurse in the State of Wisconsin.
2. Applicant's most recent address on file with the Wisconsin Department of Safety and Professional Services is 417 W. Willow Street, Chippewa Falls, WI 54729.
3. By letter dated September 16, 2014, the Board of Nursing (Board) denied Applicant's application for licensure finding that she practiced professional nursing while unlicensed.
4. By letter dated October 30, 2014, Applicant filed a timely request for hearing.
5. In resolution of the Applicant's request for hearing, the Board offered and the Applicant accepted a limited license as a registered nurse, subject to specific terms and conditions.
6. The Applicant withdraws her request for hearing.

CONCLUSIONS OF LAW

1. The Board has jurisdiction to act in this matter pursuant to Wis. Stat. §§ 441.06 and 441.07(1g) and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).

ORDER

NOW, THEREFORE, IT IS ORDERED, that VALERIE RISLOVE is GRANTED a LICENSE AS A REGISTERED NURSE subject to the following TERMS AND LIMITATIONS.

Practice Limitations



- A.1. Applicant shall use the license for the sole purpose of completing a nursing refresher course as defined by Wis. Admin. Code § N 1.12.

Termination of Order

- A.2. Upon successful completion of the refresher course, you may petition the Board for full licensure. Upon receipt of the results of the refresher course, the Board will make a decision with regard to your application. Denial of a petition in whole or in part shall not be considered a denial of a license within the meaning of Wis. Stat. § 227.01(3)(a), and Applicant shall not have a right to any further hearings or proceedings on the denial.
