ORDER

NOW, THEREFORE, IT IS ORDERED that SHERIKA THOMAS'S request to renew her PRIVATE SECURITY PERMIT is GRANTED, subject to the following LIMITATIONS, TERMS AND CONDITIONS:

Practice Limitations

1. Applicant shall show a copy of this order to her current and any future employers.

Reporting Requirements

- 2. It is Applicant's responsibility to arrange for her security guard supervisor(s) to provide work reports to the Department Monitor on a quarterly basis, as directed by the Department Monitor. These reports shall describe the Applicant's activities and verify that she is in compliance with the laws governing the practice of a private security person and the terms of this Order.
- 3. Applicant shall report to the Department any change of employment status, residence, address or telephone number within five (5) days of the date of a change. In addition, Applicant shall report any arrest or conviction within 48 hours of the arrest or entry of conviction.
- 4. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others. Applicant shall promptly notify the Department Monitor of any suspected violations of any of the terms and conditions of this Order by Applicant.

Department Monitor

5. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

Petitions for Modification

6. Applicant may petition the Department for modification of the terms of this Order after completion of one year of practice in compliance with all terms and conditions of this Order or upon full repayment of restitution, whichever is longer. Applicant's petition must include her history of employment from the effective date of this Order that states the dates and names of any employer, such employment in total equaling one year of practice. Any such petition shall be accompanied by a written recommendation from Applicant's current

employer that includes, among other things, the dates of employment and scope of responsibility during such employment, and, if applicable, her treatment provider expressly supporting the specific modifications sought. A denial of such a petition for modification shall not be deemed a denial of license under Wis. Stat. §§ 227.01(3), or 227.42, or Wis. Admin. Code ch. SPS 1, and shall not be subject to any right to further hearing or appeal.

Costs

7. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

Summary Suspension/Additional Discipline

8. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Applicant's license. The Department, in its discretion, may, in the alternative, impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event that the Applicant fails to submit quarterly reports as ordered, Applicant's license may, in the discretion of the Department or its designee, be SUSPENDED, without further notice or hearing, until Applicant has complied with the terms of this order.

The Department of Safety and Professional Services (Department) has reviewed your renewal application and has concluded that your conviction substantially relates to the practice of a private security person. The Department therefore offers you the enclosed Stipulation and Order, which would grant you a limited private security permit, subject to specified terms and conditions. A Stipulation is an agreement between the Department and yourself to recommend a resolution of this matter.

Please review the enclosed Stipulation carefully. If the Stipulation is acceptable to you, return the signed Stipulation to the Department within 45 calendar days of the date of this letter. The Department will then issue your credential, conditioned upon the terms set forth in the Order.

If you do not accept the Stipulation and Order, this letter constitutes a NOTICE OF DENIAL of your application for renewal of a full and unconditional licensure. PLEASE NOTE that you have a right to a hearing on the denial of your application if you file a request for hearing in accordance with the provisions of Wis. Admin. Code ch. SPS 1. You may request a hearing within 45 calendar days after the mailing of this notice of denial. Your request must be submitted in writing to the:

The request must contain your name and address, the type of credential for which you have applied, a specific description of the mistake in fact or law that you assert was made in the denial of your credential, and a concise statement of the essential facts which you intend to prove at the hearing. You will be notified in writing of the Department's decision. Under Wis. Admin. Code § SPS 1.08, a request for a hearing is denied if a response to a request for hearing is not issued within 45 days of its receipt by the Department. Time periods for a petition for review begin to run 45 days after the Department has received a request for a hearing and has not responded.

When you reach a customer service representative, indicate that you are calling with questions about a limited license for a private security permit.
