On September 9, 2004, the Wisconsin Chiropractic Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's chiropractic license for at least two years. On April 12, 2007, the Board issued an Order Modifying a Disciplinary Order that terminated the suspension and limited Respondent's chiropractic license with certain terms and conditions.

On March 5, 2015, the Board considered Respondent's request for removal of the limitations and the return of his license to full, unrestricted status. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of his chiropractic license (#2955-12) to full, unrestricted status is hereby GRANTED.
2. All limitations and encumbrances upon Respondent's credential are hereby removed.
3. This order is effective the date of its signing.
