On May 3, 2006, the Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice dentistry in the state of Wisconsin for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On November 4, 2015, the Board considered Respondent's request for full, unrestricted licensure. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for the return of her dentistry license (#3392-15) to full, unrestricted status is hereby DENIED as the Respondent has not demonstrated continuous successful compliance (i.e. missed check-ins). Respondent may petition for full licensure after demonstrating at least six (6) months of continuous compliance.
2. This order is effective the date of its signing.
