On May 3, 2010, the Wisconsin Cosmetology Examining Board\* ("Board") issued a Final Decision and Order ("Order") requiring Respondents to pay \$620.00 in costs of the proceeding and a \$2350.00 forfeiture via payment plan with a final payment due date of August 31, 2011.
