On May 18, 2011, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery (#48739-20) for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On October 21, 2015, the Board considered Respondent's request for a reduction in the frequency of drug and alcohol screening to 8 times per year. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for a reduction in drug and alcohol screens is approved in part. Respondent will now be required to submit to drug and alcohol screens at not less than 14 times per year plus one annual hair test.
2. This order is effective the date of its signing.
