On December 5, 2011, the Wisconsin Cosmetology Examining Board\* issued a Final Decision and Order ("Order") requiring Respondent to pay \$375.00 in costs of the proceeding and a \$250.00 forfeiture within 90 days. On August 27, 2013, Respondent's barbering or cosmetology practitioner license was suspended for failure to pay the costs of the proceeding as ordered.

Based upon the information of record, which includes proof that Respondent has now paid the costs of the proceeding in full, the following is entered:

## ORDER

The suspension is terminated and Respondent's barbering or cosmetology 1. practitioner license (#51397-82) is hereby returned to full, unrestricted status.

2. All limitations and encumbrances upon Respondent's credential are removed.

3. This order is effective the date of its signing.
