On December 14, 2011, the Wisconsin Medical Examining ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license to practice medicine and surgery. Respondent was required to complete 4 hours of education in professional ethics. The respondent was also required to submit written documentation of his weekly attendance at AA meetings pursuant to the terms of the Order.
