On January 10, 2013, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's practical nursing license with certain terms and conditions. Pursuant to the Order, Respondent's license may be suspended, without hearing, for failure to provide requested reports.

The information of record demonstrates Respondent has failed to submit a hair sample upon request and, consequently, no drug screen reports have been received by the Department Monitor. Respondent is therefore in violation of the terms of the Order and the following is entered:

1. Respondent's practical nursing license (#314512-31) is hereby SUSPENDED until further notice.
2. This order is effective the date of its signing.
