On September 18, 2013, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice medicine and surgery for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On January 21, 2015, the Board considered Respondent's request to eliminate the requirement to attend therapy. Based upon the information of record, the Board finds and makes the following:
