On April 1, 2013, the Wisconsin Cosmetology Examining Board ("Board") issued a Final Decision and Order requiring Respondent to pay a forfeiture of \$1,500.00 within 90 days. On April 15, 2014, the Board issued an Order Fixing Costs requiring Respondent to pay \$953.14 in costs of the proceeding on or before September 15, 2014. Respondent's current total balance is \$2,297.32, which includes \$44.18 in accrued interest and a recent payment of \$200.00.

On February 2, 2015, the Board considered Respondent's request for a payment plan. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for a payment plan is hereby GRANTED. Respondent shall pay \$200.00 per month until her balance is paid in full. Failure to submit timely payments will result in immediate suspension of Respondent's barbering and cosmetology practitioner license (#88571-82). The suspension would remain in effect until Respondent is compliant and up to date with the payment terms of this order.

2. All other terms and conditions of the April 1, 2013 Final Decision and Order not otherwise modified remain in full force and effect.

3. This order is effective the date of its signing.
