On July 11, 2013, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license with certain terms and conditions. Respondent was required to complete nine (9) hours of education, notify the Department Monitor of any change of employment, and enroll and participate, upon request, in a drug and alcohol monitoring program for two (2) years from the date of the Order.

Respondent's request for removal of the limitations has been received and reviewed. Based on the information of record, the following is entered:

1. Respondent's request for the removal of the limitations on his professional nursing license (#159091-30) is hereby GRANTED.
