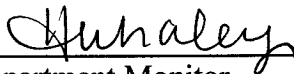
On January 9, 2014, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license. Respondent was required to complete three (3) hours of education in righting a wrong: ethics and professionalism in nursing and three (3) hours of education in patient's rights pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's professional nursing license (#116087-30) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
3. This order is effective the date of its signing.
