On March 10, 2014, the Wisconsin Board of Nursing ("Board") issued an Order for Original License ("Order"), which reinstated Applicant's professional nursing license following a previous surrender. Applicant's license was indefinitely suspended upon reinstatement and the suspension was stayed contingent upon her compliance with the terms and conditions of the Order.

Information has been received that demonstrates Applicant is in violation of the terms of the Order and, as a result, the following is entered:

ORDER

1. The stay of suspension is removed and Applicant's professional nursing license (#143136-30) is hereby SUSPENDED until further notice.
2. Applicant may petition the Board or its designee for reinstatement of the stay upon demonstrating continuous compliance with the terms and conditions of the Order for at least the most recent three (3) months.
3. This order is effective immediately.
