On March 10, 2014, the Wisconsin Board of Nursing ("Board") issued an Order for Original Limited License ("Order"), which reinstated Applicant's professional nursing license following a previous surrender. The suspension may be stayed upon Applicant providing proof that she has been in compliance with the provisions of Sections D and E of the Order for at least the most recent three (3) consecutive months.

Applicant's request for an initial stay of suspension has been reviewed pursuant to the Order. Based upon the information of record, which demonstrates that Applicant qualifies for a stay of suspension at this time, the following is entered:

ORDER

1. The suspension of Applicant's professional nursing license (#143136-30) is hereby STAYED.
2. The stay is continuous, contingent upon Applicant's compliance with the terms and conditions of the Order.
3. This order is retroactive to May 8, 2015.
