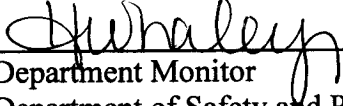

On April 15, 2014, the Wisconsin Cosmetology Examining Board issued a Final Decision and Order ("Order") requiring Respondent to pay \$194.00 in costs of the proceeding and a \$1500.00 forfeiture. Respondent was ordered to submit an initial payment of \$194.00 within 90 days and \$250.00 per month thereafter. The information of record demonstrates that Respondent has failed to pay the costs of the proceeding and forfeiture as ordered and, as a result, the following is entered:

ORDER

1. Respondent's cosmetology practitioner license (#86866-82) and her cosmetology manager license (#33142-81) are hereby SUSPENDED.
2. The suspension shall remain in effect until Respondent has paid the costs of the proceeding and forfeiture in full.
3. This order is effective the date of its signing.
