On April 10, 2014, the Wisconsin Pharmacy Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's pharmacy license for an indefinite period. Respondent has been granted a stay of suspension and her license is currently limited with certain terms and conditions.

On November 18, 2015, the Board considered Respondent's request for pharmacist in charge hours, reduction in drug and alcohol screens, a reduction in therapy and a request to change reporting from quarterly to semi-annually. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for a reduction in drug screens is hereby GRANTED. Drug screens will now be required a minimum of 36 (thirty-six) times per year plus one annual hair test.
2. Respondent's requests for pharmacist in charge hours, a reduction in therapy, and to change reporting from quarterly to semi-annually are hereby DENIED due to insufficient time under the Order. Respondent needs to work as a pharmacist in a dispensing setting before the Board will consider amending any other requirements.
3. All other terms and conditions of the Order not otherwise modified remain in full force and effect.
4. This order is effective the date of its signing.
