On May 23, 2014, the Wisconsin Department of Safety and Professional Services ("Department") issued an Order Granting Limited License ("Order") suspending Applicant's clinical substance abuse counselor license for an indefinite period. Applicant was granted an immediate stay of suspension and her license is currently limited with certain terms and conditions.

Information has been received that demonstrates Applicant is in violation of the terms of the Order and, as a result, the following is entered:

ORDER

1. The stay of suspension is removed and Applicant's clinical substance abuse counselor license (#15846-132) is hereby SUSPENDED until further notice.
2. Applicant may petition the Department or its designee for reinstatement of the stay upon demonstrating continuous compliance with the terms and conditions of the Order for at least the most recent three (3) months.
3. This order is effective immediately.
