On September 3, 2014, the Wisconsin Dentistry Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent's license to practice dentistry in the State of Wisconsin for an indefinite period. Respondent has been granted a stay of suspension and his license is currently limited with certain terms and conditions.

On November 4, 2015, the Board considered Respondent's request for a monitoring interruption (to be excused from the required drug and alcohol screens and check-ins) while he travels to Honduras for 6 weeks and volunteers as a Dentist at a free dental clinic. Based upon the information of record, the Board finds and makes the following:

ORDER

1. Respondent's request for a monitoring interruption (interruption in drug and alcohol screens and check-ins) is hereby DENIED. Applicant must comply with the terms of the Order dated September 3, 2014.
2. This order is effective the date of its signing.
