On October 28, 2014, the Wisconsin Social Worker Section of the Marriage and Family Therapy, Professional Counseling, and Social Work Examining Board ("Section") issued a Final Decision and Order ("Order") limiting Respondent's clinical social worker license. Respondent was required to complete 16 hours of education in subject matter relevant to social work pursuant to the terms of the Order.
