On November 13, 2014, the Wisconsin Board of Nursing ("Board") issued a Final Decision and Order ("Order") limiting Respondent's professional nursing license. Respondent was required to complete five (5) hours of education on documentation, six (6) hours of education on medication errors and five (5) hours of education on professional accountability pursuant to the terms of the Order.
