On January 28, 2015, the Wisconsin Veterinary Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's veterinary medicine license. Respondent was required to complete eight (8) hours of education in companion animal radiography, eight (8) hours of education in differential diagnosis of common canine illnesses, four (4) hours of education on veterinary records, eight (8) hours of education on risk management for companion animal clinical veterinary practice, and 21 hours of general veterinary continuing education pursuant to the terms of the Order.

Respondent has submitted proof that she successfully completed the required education and as a result the following is entered:

1. Respondent's veterinary medicine license (#5165-50) is returned to full, unrestricted status.
