On February 2, 2015, the Wisconsin Cosmetology Examining Board ("Board") issued a Final Decision and Order ("Order") suspending Respondent Semke's barbering or cosmetology manager license and Respondent Salon Inspired's barbering or cosmetology establishment license for an indefinite period of time.

Based upon the information of record, which includes proof that Respondent Semke has now completed the required hours under the supervision of a licensed cosmetology manager, the following is entered:

ORDER

1. The suspension is terminated and Respondent Semke's barbering or cosmetology license (#35085-81) is hereby returned to full, unrestricted status.
2. The suspension is terminated and Respondent Salon Inspired's barbering or cosmetology establishment license (#41184-80) is hereby returned to full, unrestricted status.
3. All limitations and encumbrances upon Respondents' credentials are removed.
4. This order is effective the date of its signing.
