#### FINDINGS OF FACT

1. AMANDA YOUNT (Applicant) has filed an application for a certificate of registration to practice as a real estate timeshare salesperson in Wisconsin.

2. Information received in the application process reflects that the Applicant has the following convictions/pending charges:

- a. During 2008 Disorderly Conduct
- b. On or about March 13, 2009 Operating While Revoked
- c. On or about June 15, 2009 Operating While Revoked
- d. On or about February 25, 2011 Operating While Suspended
- e. On or about May 22, 2011 Issue of Worthless Checks ( $\leq$  \$2500)
- f. On or about September 6, 2012 Operating While Suspended (4<sup>th</sup>+)
- g. On or about May 6, 2014 Misdemeanor Bail Jumping

#### CONCLUSIONS OF LAW

1. The Wisconsin Real Estate Examining Board has jurisdiction over this matter pursuant to Wis. Stat. § 452.05(1)(a).

2. The facts and circumstances of the charge(s)/convictions(s) referenced above substantially relate to the practice of a real estate timeshare salesperson.

3. Applicant by her conduct is subject to limitations against her certificate of registration pursuant to Wis. Stat. §§ 452.025(1)(b)4. and 452.14(3).

4. Limitations upon Applicant's certificate of registration are necessary to ensure that she is competent to act in a manner which safeguards the interests of the public, pursuant to Wis. Stat. § 452.025(1)(b)4.

### ORDER

NOW, THEREFORE, IT IS ORDERED that AMANDA YOUNT is GRANTED A REAL ESTATE TIMESHARE SALESPERSON CERTIFICATE OF REGISTRATION subject to the following LIMITATIONS, TERMS AND CONDITIONS:

**Practice** Limitations

- 1. Applicant shall at all times practice as a real estate timeshare salesperson under the supervision of a Wisconsin licensed real estate broker approved by the Board. Approval shall be obtained through correspondence with the Department Monitor.
- 2. Applicant shall notify her broker-employer of her history of arrests and convictions prior to employment, and shall provide a copy of this Order to her supervisor at all business entities where she works as a timeshare salesperson.
- 3. Applicant shall commit no new violations of law, and shall report all law enforcement contacts leading to arrest, charge or conviction, including DWI/OWI and municipal/ordinance violations, to the Department Monitor within 48 hours of any such event, including any conviction resulting from his pending charge.
- 4. Applicant shall not operate a motor vehicle containing a client or customer (potential or active) while practicing under this limited timeshare salesperson certificate of registration.

#### **Reporting Requirements**

- 5. Applicant shall file with the Board quarterly reports at the direction of the Department Monitor commencing ninety (90) days after Applicant commences employment. Each report shall include the following:
  - a. The name, address and telephone number of Applicant, and name, address and telephone number of his employer;
  - b. A statement from the Applicant as to whether she has had any law enforcement contacts leading to arrest, charge or conviction (including DWI/OWI and municipal/ordinance violations) during the term of the Order.

- c. Applicant shall report to the Department Monitor any change of employment status, residence, address or telephone number within five (5) days of the date of a change.
- 6. Applicant shall arrange for written reports from her supervisor(s) to be provided to Department Monitor on a quarterly basis, as directed by Department Monitor. These reports shall assess Applicant's work performance and describe the circumstances of her employment, including the nature and extent of the Applicant's sales activities and whether she has practiced in compliance with all laws governing the practice of real estate timeshare sales.
- 7. Applicant is responsible for compliance with all of the terms and conditions of this Order, including the timely submission of reports by others. Applicant shall promptly notify Department Monitor of any suspected violations of any of the terms and conditions of this Order.
- 8. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order. Any requests, petitions, reports or other information required by this Order shall be mailed, faxed or delivered to:

## Petitions for Modification

9. Applicant may petition the Department Monitor for modification of the terms of this Order after completion of two years of practice in compliance with all terms and conditions of this Order. "Practice in compliance" includes the submission of work reports, the content of which are satisfactory to the Board. Applicant's petition must include her history of employment from the effective date of this Order that states the dates and names of any employer, such employment in total equaling two years of practice. Any such petition shall be accompanied by a written recommendation from Applicant's current employer that includes, among other things, the dates of employment and scope of responsibility during such employment. A denial of such a petition for modification shall not be deemed a denial of license under Wis. Stat. §§ 227.01(3), or 227.42, or Wis. Admin. Code ch. SPS 1, and shall not be subject to any right to further hearing or appeal.

#### <u>Costs</u>

10. Applicant shall be responsible for all costs and expenses associated with compliance with the terms of this Order.

#### Summary Suspension/Additional Discipline

11. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a summary suspension of Applicant's certificate of registration. The Board, in its discretion, may, in the alternative, impose additional conditions and limitations or other additional discipline for a violation of any of the terms of this Order. In the event that Applicant fails to submit quarterly reports as ordered, Applicant's certificate of registration may, in the discretion of the Real Estate Examining Board or its designee, be SUSPENDED, without further notice or hearing, until Applicant has complied with the terms of this order.
