On February 11, 2015, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's residential appraiser certification. Respondent was required to complete eight (8) hours of education in HMS1-ANS1 Home Measurement and the Power of Price-Per-Square Foot, six (6) hours of education in HMS2 – The Home Valuation Crisis-Public Records and Square Footage, fifteen (15) hours of education in Residential Site Valuation and Cost Approach, fifteen (15) hours of education in Residential Report Writing and Case Studies, fifteen (15) hours of education in USPAP, and five (5) hours of education in Data Verification Methods pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's residential appraiser certification (#1692-9) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
