On February 11, 2015, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's residential appraiser certification with certain terms and conditions.

On August 3, 2015, the Board considered Respondent's request for the Board to waive his requirement to complete the examinations for his three (3) continuing education courses and for a second extension on the due date of his continuing education. Based upon the information of record, the Board finds and makes the following:

ORDER

Respondent's request to waive the examination requirements for the Residential 1. Site Valuation and Cost Approach and Residential Sales Comparison and Income Approach courses is GRANTED.

Respondent's request for a second extension to complete the 15-hour USPAP 2. course is hereby GRANTED until 10/24/2015.

Respondent's request to waive the examination requirement for the 15 hour 3. USPAP course is DENIED. In the alternative, the Board allows Respondent to take the 15 hour USPAP course either online or in person.

All other terms and conditions of the Order not otherwise modified remain in full 4. force and effect.
