The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Real Estate Appraisers Board (Board). The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Respondent Allen L. Baehr (dob May 11, 1943) is licensed in the State of Wisconsin as a Licensed Appraiser, having certificate of licensure number 1479-4, first issued on August 16, 2002, and current through December 14, 2015. Respondent's most recent address on file with the Wisconsin Department of Safety and Professional Services (Department) is 2616 Happy Valley Road, Sun Prairie, WI 53590.
- 2. On September 12, 2007, Respondent was disciplined by the Board for violations of the Uniform Standards of Professional Appraisal Practice (USPAP). Respondent was suspended for forty five (45) days, ordered to complete education related to business practices and ethics, basic appraisal principles and basic appraisal procedures and pay costs of \$1000.

- 3. Between December 2012 and January 2013, Respondent completed appraisals for properties located at 33453 Jeidy Hill Rd., Wauzeka, WI 53826, 710 Avalon Rd., Columbus, WI 53925, and 604 Pine St., Boscobel, WI 53805.
- 4. In March 2013, the Department received a complaint alleging Respondent's appraisals contained multiple errors. Division of Legal Services and Compliance (DLSC) Case Number 13 APP 008 was subsequently opened for investigation.
- 5. On September 11, 2012, Respondent completed an appraisal for a property located at County Road MM, Watertown, WI 53047.
- 6. In July 2013, the Department received a complaint alleging Respondent's appraisal contained multiple errors. DLSC Case Number 13 APP 045 was subsequently opened for investigation.
- 7. Respondent's appraisals were reviewed by DLSC, and it concluded that the appraisals and appraisal reports violated USPAP Rules and/or Standards Rules.
- 8. Respondent does not admit to any violations alleged in DLSC Case Numbers 13 APP 008 and 13 APP 045, but he does not wish to contest them.
- 9. Respondent wishes to resolve DLSC Case Numbers 13 APP 008 and 13 APP 045 pursuant to the voluntary surrender of his certificate of licensure as a Licensed Appraiser.

CONCLUSIONS OF LAW

- 1. The Wisconsin Real Estate Appraisers Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 458.26, and is authorized to enter into the attached Stipulation pursuant to Wis. Stat. § 227.44(5).
- 2. As a result of the USPAP violations referenced above, Respondent is subject to discipline pursuant to Wis. Stat. § 458.26(3)(b), (c) and (i).

ORDER

- 1. The attached Stipulation is accepted.
- 2. The VOLUNTARY SURRENDER of Respondent Allen L. Baehr's Licensed Appraiser certificate of licensure (number 1479-4) is hereby ACCEPTED.
- 3. This surrender constitutes Respondent's permanent relinquishment of his right to renew or reinstate his Licensed Appraiser certificate of licensure. The Board will not, at any time in the future, process or otherwise consider an application for or attempt at renewal or reinstatement of a certificate of certification or licensure.

4. This Order is effective on the date of its signing.

ORDER 0003717

Division of Legal Services and Compliance Case Nos. 13 APP 008 and 13 APP 045

Respondent Allen L. Baehr and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation.
- 4. Respondent agrees to the adoption of the attached Final Decision and Order by the Wisconsin Real Estate Appraisers Board (Board). The parties to the Stipulation consent to the entry of the attached Final Decision and Order without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Board's order, if adopted in the form as attached.
- 5. If the terms of this Stipulation are not acceptable to the Board, the parties shall not be bound by the contents of this Stipulation, and the matter shall then be returned to the Division

of Legal Services and Compliance for further proceedings. In the event that the Stipulation is not accepted by the Board, the parties agree not to contend that the Board has been prejudiced or biased in any manner by the consideration of this attempted resolution.

- 6. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance and any member of the Board ever assigned as an advisor in this investigation may appear before the Board in open or closed session, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that any member of the Board may have in connection with deliberations on the Stipulation. Additionally, any such advisor may vote on whether the Board should accept this Stipulation and issue the attached Final Decision and Order.
- 7. Respondent is informed that should the Board adopt this Stipulation, the Board's Final Decision and Order is a public record and will be published in accordance with standard Department procedure.
- 8. The Division of Legal Services and Compliance joins Respondent in recommending the Board adopt this Stipulation and issue the attached Final Decision and Order.
