PROCEDURAL HISTORY

This matter comes before the Wisconsin Cosmetology Examining Board (Board) as a citation to which Respondents Cut For You LLC and Pavli Samara have made no timely response. Based on the record in this case, the Board adopts as its Final Decision in this matter the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Respondent Cut For You LLC which is licensed in the State of Wisconsin as a cosmetology establishment, having license number 39062-80, first issued on December 9, 2011 and current through March 31, 2015. Cut For You LLC's most recent address on file with the Department of Safety and Professional Services (Department) is 1250 Milton Avenue, Suite 100, Janesville, Wisconsin 53545.

2. Respondent Pavli Samara is the owner of Cut For You LLC. Pavli Samara's most recent address on file with the Department is 303 Park Street, Apt. 6, Fort Atkinson, Wisconsin 53538.

3. On May 1, 2013, Respondents telephoned the Department and reported that they were operating their establishment even though the establishment's license had expired on April 1, 2013.

4. On January 21, 2015, a Division of Legal Services and Compliance (Division) investigator issued a \$250 citation to Respondents for participating in the unlicensed practice of cosmetology. Service was accomplished by mail. A true and correct copy of this citation is attached as Exhibit A and is incorporated herein by reference.

5. Respondents have not paid the citation that was issued to Respondents on January 21, 2015.

CONCLUSIONS OF LAW

1. The Wisconsin Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Wis. Stat. § 454.15.

2. Respondents violated Wis. Admin. Code § Cos 2.04(1) by participating in the unlicensed practice of cosmetology.

3. As a result, Respondents are subject to discipline pursuant to Wis. Stat. § 454.15(2)(i) and (3).

4. Respondents are in default pursuant to Wis. Admin. Code § Cos 10.07(1) for failing to make a deposit or otherwise respond to the citation in a timely fashion.

5. Pursuant to Wis. Admin. Code § Cos 10.07(1), the Board has the authority to issue an order of default against Respondents for the amount identified in the citation without further proceedings.

ORDER

1. Respondents are in DEFAULT and shall pay to the Wisconsin Department of Safety and Professional Services a total forfeiture in the amount of \$250 within thirty (30) days from the date of this Order.

3. Violation of any of the terms of this Order may be construed as conduct imperiling public health, safety and welfare and may result in a refusal to renew a credential or additional disciplinary action.
