The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Wisconsin Department of Safety and Professional Services (Department). The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department adopts the attached Stipulation and makes the following Findings of Fact, Conclusions of Law and Order.

FINDINGS OF FACT

- 1. Daniel Rieder (Respondent) is not and has never been licensed as a veterinarian pursuant to Wis. Stat. § 453.06.
- 2. Respondent's most recent address on file with the Department of Safety and Professional Services is W5478 County Road DR, Monroe, Wisconsin 53566.
- 3. For at least nineteen years, Respondent has provided commercial bovine embryo transfer services in the state of Wisconsin.

- 4. In performing tasks required for bovine embryo transplant services, Respondent has examined into the fact of animal health and physical condition. He has also advised others about the fact of animal health and physical condition.
- 5. Respondent offers and provides embryo transfer services in the state of Wisconsin for compensation.
- 6. Respondent neither admits nor denies the allegations but consents to entry of the Conclusions of Law and Order below.

CONCLUSIONS OF LAW

- 1. The Wisconsin Department of Safety and Professional Services has jurisdiction in this matter pursuant to Wis. Admin. Code ch. SPS 3 and Wis. Stat. § 440.21, and is authorized to enter into the attached Stipulation and Order pursuant to Wis. Stat. § 227.44(5).
 - 2. Pursuant to Wis. Stat. § 453.02(6) "to practice veterinary medicine" means:

To examine into the fact or cause of animal health, disease or physical condition, or to treat, operate, prescribe or advise for the same, or to undertake, offer, advertise, announce, or hold out in any manner to do any of said acts, for compensation, direct or indirect or to treat, operate, prescribe or advise for the same, or to undertake, offer, advertise, announce, or hold out in any manner to do any of said acts, for compensation, direct or indirect, or in the expectation thereof.

- 3. Pursuant to Wis. Stat. § 453.05, subject to statutory exceptions that are inapplicable to the instant case, a license is required to practice veterinary medicine.
- 4. The conduct set out in paragraphs 3-5 in the Findings of Fact, above, constitutes the practice of veterinary medicine for which licensure is required.
 - 5. Respondent has violated the licensure requirements set out in Wis. Stat. § 453.05.
- 6. Pursuant to Wis. Stat. § 440.21, Respondent is subject to this special order of administrative injunction.

ORDER

- 1. The attached stipulation is accepted.
- 2. Unless and until Respondent is properly licensed by the Wisconsin Veterinary Examining Board, Respondent is enjoined and prohibited from engaging in acts constituting the practice of veterinary medicine in the state of Wisconsin. Violation of this special order may result in a forfeiture of up to \$10,000 for each day of violation. See Wis. Stat. § 440.21(4)(a).

3. If the Department determines that there is probable cause to believe that Respondent has violated any terms of this Administrative Injunction, the Department may refer the violations covered by this decision and order to any appropriate prosecutorial unit for review for possible criminal charges.

Respondent Daniel Rieder and the Division of Legal Services and Compliance, Department of Safety and Professional Services stipulate as follows:

- 1. This Stipulation is entered into as a result of a pending investigation by the Division of Legal Services and Compliance. Respondent consents to the resolution of this investigation by Stipulation.
- 2. Respondent understands that by signing this Stipulation, Respondent voluntarily and knowingly waives the following rights:
 - the right to a hearing on the allegations against Respondent, at which time the State has the burden of proving those allegations by a preponderance of the evidence;
 - the right to confront and cross-examine the witnesses against Respondent;
 - the right to call witnesses on Respondent's behalf and to compel their attendance by subpoena;
 - the right to testify on Respondent's own behalf;
 - the right to file objections to any proposed decision and to present briefs or oral arguments to the officials who are to render the final decision;
 - the right to petition for rehearing; and
 - all other applicable rights afforded to Respondent under the United States Constitution, the Wisconsin Constitution, the Wisconsin Statutes, the Wisconsin Administrative Code, and other provisions of state or federal law.
- 3. Respondent is aware of Respondent's right to seek legal representation and has been provided an opportunity to obtain legal counsel before signing this Stipulation. Respondent is represented by Attorney Robert S. Duxstad.
- 4. Respondent agrees to the adoption of the attached Administration Injunction by the Wisconsin Department of Safety and Professional Services (Department). The parties to the Stipulation consent to the entry of the attached Administrative Injunction without further notice, pleading, appearance or consent of the parties. Respondent waives all rights to any appeal of the Department's Order, if adopted in the form as attached.

- 5. The parties to this Stipulation agree that the attorney or other agent for the Division of Legal Services and Compliance may appear before the Department, without the presence of Respondent, for purposes of speaking in support of this agreement and answering questions that the Department may have in connection with deliberations on the Stipulation.
- 6. Respondent is informed that should the Department adopt this Stipulation, the Department's Administrative Injunction is a public record and will be published in accordance with standard Department procedure.
- 7. The Division of Legal Services and Compliance joins Respondent in recommending that the Department adopt this Stipulation and issue the attached Administrative Injunction.
