
On May 6, 2015, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's Certified Residential Appraiser's license. Respondent was required to complete 15 hours of education in National USPAP, 15 hours of education in Advanced Residential Applications and Case Studies, 15 hours of education in Residential Site Comparison and Cost Approach, and 15 hours of education in Residential Market Analysis and Highest and Best Use pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

ORDER

1. Respondent's Certified Residential Appraiser's license (#1266-9) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
