On May 6, 2015, the Wisconsin Real Estate Appraisers Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's license. Respondent was required to complete 30 hours of education in Basic Appraisal Principles, 15 hours of education in Residential Site Valuation and Cost Approach, 15 hours of education in Residential Market Analysis and Highest and Best Use, 30 hours of education in Residential Sales Comparison and Income Approach, 8 hours of education in HMS 1-ANSI, Home Measurement and the Power of Price Per Square Foot, 6 hours of education in HMS 2- The Home Valuation Crisis-Public Records & Square Footage pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:

1. Respondent's license (1807-4) is returned to full, unrestricted status.
2. All limitations and encumbrances upon Respondent's credential are removed.
