On June 17, 2015, the Social Worker Section of the Marriage and Family Therapy, Professional Counseling and Social Work Examining Board issued its Final Decision and Order in the above-captioned matter by which the Section ordered that pursuant to Wis. Stats. § 440.22, the costs of this proceeding be assessed against Respondent. The Section received the Affidavits of costs from the Division of Legal Services and Compliance and the Division of Hearings and Appeals. The Section considered the Affidavits of Costs on November 17, 2015, and orders as follows:

ORDER


NOW, THEREFORE, IT IS ORDERED that pursuant to Wis. Stats. § 440.22, that the costs of this proceeding in the amount of \$558.46 are hereby assessed against the Respondent, and shall be payable by the Respondent to the Department of Safety and Professional Services. **Failure of Respondent to make payment on or before November 17, 2016, shall constitute a violation of the Order unless the Respondent petitions for and the Section grants a different deadline.** Under Wis. Stats. § 440.22(3), the Department of Safety and Professional Services may not restore, renew or otherwise issue any credential to the Respondent until the Respondent has made payment to the Department in the full amount assessed.
