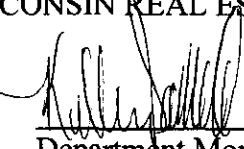
On June 18, 2015, the Wisconsin Real Estate Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's timeshare salespersons license. Respondent was required to complete three hours of education in ethics pursuant to the terms of the Order.
