On August 19, 2015, the Wisconsin Medical Examining Board ("Board") issued a Final Decision and Order ("Order") limiting Respondent's medicine and surgery license. Respondent was required to complete 10 hours of education in gastric band removal, gastric band bariatric surgery or related abdominal surgery pursuant to the terms of the Order.

Respondent has submitted proof that he successfully completed the required education and as a result the following is entered:
